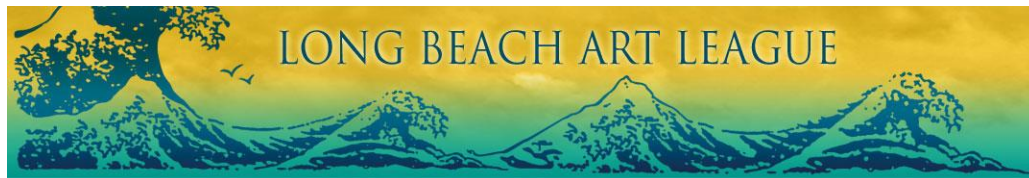

AITP Responsibilities of the Participants

- All Exhibitors must hold a current membership to one of the three sponsoring non-profit 502(c)3 organizations:
 - Long Beach Art League - www.longbeachartleague.com
 - Artists in Partnership, Inc. - www.aip-arts.org
 - West End Arts Visual Artists Guild, Inc. - www.westendarts.org
 - Individual membership is \$25 for the art group of your choice (current memberships are valid).
- The vendor fee for Arts In The Plaza is \$400 for unlimited Saturdays from May 27-Oct. 28, 2017 (not including June 3 and Oct 14). Returning vendors receive a discounted vendor fee of \$275.
- Only original, handcrafted work is permitted to be exhibited.
- You must submit at least one photograph of you creating your art.
- Setup is 8am to 10am. No setup is permitted before 8am.
- Vendors must check in with the manager each week prior to setting up.
- All vehicles must be parked in the designated area behind City Hall with an AITP Parking Permit displayed. This will be strictly enforced.
- Spaces are approximately 10' x 10' and will be assigned by the manager.
- Occasionally spaces are reserved for musical performances or for the use of sponsoring organizations and are unavailable.
- You must bring your own setup. Arts In The Plaza does not provide tents, chairs, tables or racks.
- All tents, display racks and displays must be appropriately weighted and anchored in accordance with the manufacturer's specifications. We require a minimum of 8 pounds on each tent leg.
- Each vendor is responsible for cleaning up and bagging any trash in their area.
- You are responsible for your booth and your artwork at all times.
- You are responsible for obtaining your own liability insurance coverage, if you choose.
- NYS law requires that you register with the Tax Department and obtain a *Certificate of Authority*.
- Vendors are expected to keep their booths set up from 10 am to 3 pm.
- In the event of inclement weather, please call (516) 507-8383 to check on event status.
- If our event is cancelled due to weather we will notify you via email.

AITP Waiver

Arts In The Plaza retains, at their absolute discretion, the right to prohibit any craftsperson from exhibiting. We reserve the right to accept and/or deny any vendor. Vendors may be immediately required to remove any items not consistent with our high artistic standards. If a vendor fails to comply with any or all of the Responsibilities of the Participants, they may be required to leave the show without further notice or recourse and without a refund of any money paid.

There are a limited number of spots, and quotas will be set by Arts In The Plaza on all merchandise.

The Exhibitor agrees that he/she is solely responsible for his/her work, person and property at all times and will not hold Arts In The Plaza responsible or liable for any losses or damages to property or injury to person.
